ITEM NO.01:

Technical Evaluation for Uninterrupted Power Supply (UPS)

RESO.NO.01:

It is stated that only four companies participated in the tender for the Supply of UPS, and the Board had called all the bidders to show their Samples and provide demo.

Out of three bidders only one bidders named M/s GEMCO appeared for the technical assessment to Sub-Committee.

During the technical evaluation of the committee, it was observed that the UPS of M/s GEMCO is made according to the International Standards and it has extra features like Synthesizer with stabilizer and transformer with its circuits and up to the mark of International Standards.

Therefore, the Technical Sub-Committee decided that the UPS of M/s GEMCO is the better choice for BIE, Karachi.

M/S Verson and M/s Indasy did not come for the Technical evaluation nor provided any Sample according to the tender terms and conditions.

ITEM NO.02:

Technical Evaluation for Scanners

RESO.NO.02:

It is stated that only five companies participated in the tender for the Supply of Scanners, and the Board had called all the bidders to show their Samples and provide demo of it.

Out of five bidders only three bidders Named M/s GEMCO, M/s GRAPHO, and M/s SEESAM appeared for the technical assessment to the Sub-Committee.

M/s GEMCO offered Kodak brand but did not provide any sample and not shown any demo to the Technical Sub-Committee.

M/s GRAPHO offered AVISION Brand, which is the requirement according to the specification of Tender, but they have not shown the sample and any demo. During discussion with M/s GRAPHO the committee is not satisfy their expertise level at that time, But

they are asking to show the sample and demo about 10 working they are asking to show the sample and demo about 10 working days, which is starting from official letter given to them. And after these days, they have to show the features that IT Section has required like multiple zone scanning etc. In case, if they cannot show the sample and other features, so committee will not entertain them
